If a Credit Event Determination Date occurs, the entire amount of principal is at risk and the Notes shall be redeemed at the zero on the Credit Event Redemption Date as specified in paragraph 40 above. Also, the Notes shall cease to bear interest from the Interest Payment Date immediately preceding the Credit Event Determination Date (or no interest shall be paid at all if a Credit Event Determination Date occurs prior to the first Interest Payment Date).
