This document constitutes the Pricing Supplement relating to the issue of Notes described herein. Terms used herein shall be deemed to be defined as such for the purposes of the Terms and Conditions of the English Law Notes set forth in the Offering Circular dated 27 June 2013 and the supplement to the Offering Circular dated 16 October 2013, 09 January 2014, 24 April 2014, 29 May 2014 and 19 June 2014 (together, the "**Offering Circular**"). This Pricing Supplement must be read in conjunction with such Offering Circular as so supplemented. Full information on the Issuer and the offer of the Notes is only available on the basis of the

Information Concerning Investment Risk

Noteholders and prospective purchasers of Notes should ensure that they understand the nature of the Notes and the extent of their exposure to risk and that they consider the suitability of the Notes as an investment in the light of their own circumstances and financial condition. The amount payable on redemption of the Notes is linked to the performance of the Underlying (as defined herein), and may be less than par. In such circumstances, the Determination Agent can in its sole and absolute discretion determine whether to redeem the Securities early, or adjust the terms of the Securities, which may include without limitation adjustments to the Initial Reference Price, the Final Redemption Amount or the Underlying. The Determination Agent is not required but has the discretion to make adjustments with respect to each and every corporate action. Adjustment and Discontinuation Risk: The Sponsor or issuer of the Underlying can add, delete or substitute stocks or other underlying constituents constituting the Underlying or make other methodological changes that could change the value of the Underlying without regard to the interests of holders of the Notes. Any of these decisions/determinations may adversely affect the value of the Notes and may result in the investor receiving a return that is materially different from what he/she would have received if the event had not occurred.

Credit Risk: Investors are exposed to the credit risk of the Issuer and/or Guarantor. The Notes are essentially a loan to the Issuer with a repayment amount linked to the performance of the Underlying that the Issuer promises to pay to you at maturity and that the Guarantor promises to pay to you if the Issuer fails to do so. The secondary market price may be lower than the market value of the issued Notes as at the Issue Date to take into account amounts paid distributors and other intermediaries relating to the issue and sale of the Notes as well as amounts relating to the hedging of the Issuer's obligations. As a result of all of these factors, the holder may receive an amount in the secondary market which may be less than the then intrinsic market value of the Note and which may also be less than the amount the holder would have received had the holder held the Note through to maturity.

Liquidity Risk: Any secondary market in the Notes made by the Dealer will be made on a reasonable efforts basis only and subject to market conditions, law, regulation and internal policy. Even whilst there may be a secondary market in the Notes it may not be liquid enough to facilitate a sale by the holder.

Hedging Risk: On or prior to and after the Trade Date, the Issuer, through its affiliates or others, will likely hedge its anticipated exposure under the Notes by taking positions in the Underlying, in option contracts on the Underlying or positions in any other available securities or instruments. In addition, the Issuer and its affiliates trade the Underlying as part of their general businesses. Any of these activities could potentially affect the value of the Underlying, and accordingly, could affect the pay-out to holders on the Notes.

No Shareholder Rights: A holder of Notes will have no beneficial interest in the stocks that compose the relevant Underlying nor any voting rights and will not have the right to receive dividends or other distributions with respect to the stocks that compose the Underlying.

Potential Conflict of Interest: The Determination Agent, which is an affiliate of the Issuer, will determine the pay-out to the investor at maturity. Morgan Stanley & Co. International plc and its affiliates may trade the Underlying on a regular basis as part of its general broker-dealer business and may also carry out hedging activities in relation to the Notes. Any of these activities could influence the Determination Agent's determination of adjustments made to any Notes and any such trading activity could potentially affect the price of the Underlying and, accordingly, could affect the investor's pay-out on any Note.

Underlying Sponsor Risk: The Sponsor or issuer of the relevant Underlying is not an affiliate of the Issuer or its affiliates and is not involved with this offering in any way. Consequently, the Issuer and the Determination Agent have no ability to control the actions of the Sponsor of the relevant Underlying, including and rebalancing that could trigger an adjustment to the terms of the Notes by the Determination Agent.

Market Risk: Price movements in the components of the Underlyings or of the Fund may not correlate with each other. Increases in the value of one or more of the components may be moderated, or wholly offset, by lesser increases or declines in the value of one or more of the other components.

Risks specific to the Strategy:

Strategy risk: As well as to the performance of the Underlying Index, the Notes are also linked to the performance of a Basket in which a proprietary strategy is applied to a UCITs Fund. The strategy is quantitative and rules-based and can produce negative returns. The strategy methodology was developed based on historic data and conditions and there can be no assurance that the methodology can generate positive performance in the future.

Volatility Control Risk

Under the Strategy, the exposure to the Fund depends on the estimated level of realised volatility of the Fund. If the estimated realised volatility exceeds the target volatility, the noteholder will have reduced participation to the performance of the Fund, compared to a direct investment in the Fund. The volatility levels are monitored on a daily basis.

The aim of the Strategy is to protect against sharp falls in the Fund. As volatility tends to be negatively correlated with performance, there may be a diversification benefit for holders of direct investments in the Fund. During periods of market uncertainty, where large single day price movements can cause a rise

in volatility, the volatility control mechanism will reduce exposure to the Fund, providing a partial hedge for sharp falls in underlying Fund.

However, there is no guarantee that the volatility control will reduce or cushion losses of the Noteholders. If the value of the Fund decreases, but the estimated realised volatility is below the target volatility, the exposure to the Fund will not be reduced.

No Interest

The Noteholder will not be entitled to an interest rate return on the Cash Component since the performance of Morgan Stanley-PSAM Global Event UCITS 4.00% Volatility Target Basket is based on a return calculation in excess of the return of a cash investment.

Leverage

The participation to the Fund is leveraged (unless reduced through the volatility strategy). The value of the Note may decrease significantly more than the value of the Fund.


