PROGRAMME FOR THE ISSUANCE OF DEBT INSTRUMENTS AND S.O. BONDS

This base prospectus supplement dated 2 February 2016 (the “**Supplement**”) to the Base Prospectus dated 13 May 2015 (together with the Supplements dated 16 July and 20 October 2015, the “**Base Prospectus**”) constitutes a supplement for the purposes of Article 16 of Directive 2003/71/EC, as amended (the “**Prospectus Directive**”) and is prepared in connection with the Programme for the Issuance of Debt Instruments and S.O. Bonds (the “**Programme**”) established by Swedbank Mortgage AB (publ) (the “**Company**”) and guaranteed by Swedbank AB (publ) (the “**Guarantor**”). Terms defined in the Base Prospectus have the same meaning when used in this Supplement.

This Supplement has been approved by the Central Bank of Ireland as competent authority under the Prospectus Directive. The Central Bank of Ireland only approves this Supplement as meeting the requirements imposed under Irish and European law pursuant to the Prospectus Directive.

The purpose of this Supplement is to incorporate by reference into the Base Prospectus the year-end reports of the Company and the Guarantor for the twelve month period ended 31 December 2015.

This Supplement is supplemental to, and should be read in conjunction with the Base Prospectus issued by the Company.

The Company and the Guarantor accept responsibility for the information contained in this Supplement. To the best of the knowledge of the Company and the Guarantor (having taken all reasonable care to ensure that such is the case) the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

Publication of Year-end Reports for Swedbank Mortgage AB (publ) and Swedbank AB (publ)

On 2 February 2016 the Company and the Guarantor published its reviewed unaudited year-end report for the twelve month period ended 31 December 2015. Copies of the year-end reports have been filed with the Central Bank of Ireland and, by virtue of this Supplement, the year-end reports are incorporated in, and forms part of, the Base Prospectus. If documents which are incorporated by reference to this Supplement themselves incorporate any information or other documents therein, either expressly or implicitly, such information or other documents will not form part of this Supplement for the purposes of the Prospectus Directive except where such information or other documents are specifically incorporated by reference to the Supplement.

Save as disclosed in this Supplement, there has been no other significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus since the publication of the Base Prospectus.
