This base prospectus supplement dated 17 May 2017 (the "Supplement") to the base prospectus dated 6 January 2017, as supplemented by the 1st base prospectus supplement dated 7 March 2017 and the 2nd base prospectus supplement dated 21 March 2017 (the "Base Prospectus"), which comprises a base prospectus under Article 5.4 of the Prospectus Directive for the Fédération des caisses Desjardins du Québec (the "Federation" or the "Issuer"), constitutes a supplement for purposes of Article 16 of the Prospectus Directive and is prepared in connection with the C\$10,000,000,000 Global Covered Bond Programme of the Federation, unconditionally and irrevocably guaranteed as to payments by CCDQ Covered Bond (Legislative) Guarantor Limited Partnership (the "Guarantor"), established by Fédération des caisses Desjardins du Québec (the "Programme").

Terms defined in the Base Prospectus have the same meaning when used in this Supplement. This Supplement is supplemental to, and shall be read in conjunction with, the Base Prospectus. This Supplement has been approved by the Central Bank of Ireland as competent authority under the Prospectus Directive. The Central Bank of Ireland approves this Supplement as meeting the requirements imposed under Irish and European law pursuant to the Prospectus Directive.

The Federation and the Guarantor accept responsibility for the information in this Supplement. To the best of the knowledge of the Federation and the Guarantor, having taken reasonable care to ensure that such is the case, the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

The purpose of this Supplement is to incorporate by reference in the Base Prospectus: (a) the Federation's unaudited condensed interim consolidated financial statements as at and for the three-month period ended 31 March 2017, together with management's discussion and analysis thereof; (b) the Federation's unaudited coverage ratio annex as at 31 March 2017; (c) the Desjardins Group's unaudited condensed interim combined financial statements as at and for the three-month period ended 31 March 2017, together with management's discussion and analysis thereof; (d) the Desjardins Group's coverage ratio annex as at 31 March 2017; and (e) the Federation's latest monthly investor reports for the months of March 2017 and April 2017 containing information on the Covered Bond Portfolio.

Save as disclosed in this Supplement, no significant new factor, material mistake or inaccuracy relating to the information included in the Base Prospectus which is capable of affecting the assessment of Covered Bonds issued under the Programme has arisen or been noted, as the case may be, since the publication of the 2nd base prospectus supplement dated 21 March 2017.

THE COVERED BONDS HAVE NOT BEEN APPROVED OR DISAPPROVED BY CANADA MORTGAGE AND HOUSING CORPORATION ("CMHC") NOR HAS CMHC PASSED UPON THE ACCURACY OR ADEQUACY OF THIS SUPPLEMENTARY PROSPECTUS. THE COVERED BONDS ARE NOT INSURED OR GUARANTEED BY CMHC OR THE GOVERNMENT OF CANADA OR ANY OTHER AGENCY THEREOF.

To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Base Prospectus by this Supplement and (b) any other statement in, or incorporated by reference in, the Base Prospectus, the statements in (a) above will prevail.
