This Prospectus Supplement dated 19 February 2014 ("Prospectus Supplement No. 4") to the Reference Item-Linked Base Prospectus dated 21 June 2013 (the "Original Base Prospectus" and, together with the Prospectus Supplement dated 7 August 2013 ("Prospectus Supplement No. 1"), the Prospectus Supplement No. 2 dated 1 November 2013 ("Prospectus Supplement No. 2") and the Prospectus Supplement No. 3 dated 11 February 2014 ("Prospectus Supplement No. 3") and Prospectus Supplement No. 4, the "Base Prospectus") constitutes a prospectus supplement for the purposes of Article 16 of Directive 2003/71/EC, as amended (the "Prospectus Directive") and is prepared in connection with the Structured Note Programme (the "Programme") established by Danske Bank A/S (the "Issuer"). Terms defined in the Base Prospectus have the same meaning when used in this Prospectus Supplement No. 4.

This Prospectus Supplement No. 4 has been approved by the Central Bank of Ireland as competent authority under the Prospectus Directive. The Central Bank of Ireland only approves this Prospectus Supplement No. 4 as meeting the requirements imposed under Irish and European law pursuant to the Prospectus Directive.

Application has been made to the Irish Stock Exchange for the approval of this Prospectus Supplement No. 4 as a Listing Particulars Supplement ("Listing Particulars Supplement").

Where Notes are admitted to trading on the global exchange market (the "Global Exchange Market") which is the exchange regulated market of the Irish Stock Exchange, references herein to "Prospectus Supplement No. 4" should be taken to mean "Listing Particulars Supplement".

The Issuer accepts responsibility for the information contained in this Prospectus Supplement No. 4. To the best of the knowledge of the Issuer (which has taken all reasonable care to ensure that such is the case) the information contained in this Prospectus Supplement No. 4 is in accordance with the facts and does not omit anything likely to affect the import of such information.

 - "A Worst of Autocall Event will occur if the lowest or equal lowest autocall performance of any Reference Item in respect of a specified autocall valuation date (the "Worst of Autocall Performance") (other than the final specified autocall valuation date) is greater than or equal to the relevant Autocall Barrier (being the percentage specified in the relevant Issue Terms or the percentage specified for an autocall valuation date in the relevant Issue Terms).";
- (ii) In the sub-section entitled "Examples of the calculation of the Worst of Autocall Early Redemption Amount and the Worst of Autocall Redemption Amount:" the reference to the Autocall Barrier shall be deleted and replaced by the words "Autocall Barrier: 100% for all the autocall valuation dates"; and
- (iii) Other than as set out above, all other references to "Autocall Barrier" set out therein shall be deemed to be references to the "relevant Autocall Barrier"

4. Flex Autocall Redemption

4.1 Description of the Notes

The following shall be inserted as a new paragraph 30 (*Reference Item-Linked Redemption Amount* = *Flex Autocall Redemption*) of Section B.2 (*Description of the Notes*) of the Original Base Prospectus:

"30. FLEX AUTOCALL REDEMPTION

Where the Issue Terms relating to a Tranche of Notes specifies that "Flex Autocall" is applicable, based on the economic performance of a Reference Item or a basket of Reference Items, such Notes give the investor a right to receive either an Early Redemption Amount or a Final Redemption Amount which will be determined in accordance with the formulae set out below. Such Notes may be Index-Linked Notes (linked to an Index or a basket of Indices), Equity-Linked Notes (linked to an Underlying Equity or a basket of Underlying Equities), Fund-Linked Notes (linked to a Fund Interest or a basket of Fund Interests), Currency-Linked Notes (linked to an FX Rate or a basket of FX Rates) or Commodity-Linked Notes (linked to a Commodity or a basket of Commodities).

Early Redemption Amount

If a Flex Autocall Event occurs, the Notes will be redeemed early by payment of the Flex Autocall Early Redemption Amount in respect of each Calculation Amount ("CA") determined by reference to the following formula:

CA + [CA x t x Autocall Percentage]

A Flex Autocall Event will occur if the Relevant Autocall Performance in respect of a specified autocall valuation date (other than the final specified autocall valuation date) is greater than or equal to the relevant Autocall Barrier (being the percentage specified in the relevant Issue Terms or the percentage specified for an autocall valuation date in the relevant Issue Terms).

Relevant Autocall Performance is determined as the autocall performance of the Reference Item (where the Notes relate to a single Reference Item) or the sum of the weighted autocall performances of each of the Reference Items (where the Notes relate to a basket of Reference Items).

The autocall performance of any Reference Item is determined as the value of the relevant Reference Item in respect of the relevant specified autocall valuation date divided by the value or the average value of the relevant Reference Item in respect of specified initial valuation date(s).

The Autocall Percentage is determined as either the fixed percentage specified in the relevant Issue Terms or, if Performance Percentage is specified as applicable in the relevant Issue Terms, the greater of (i) such fixed percentage and (ii) the Relevant Autocall Performance MINUS 100%.

"t" is the number assigned to the specified autocall valuation date in respect of which the relevant Flex Autocall Event occurs.

Final Redemption Amount

If a Flex Autocall Event does not occur, the Notes will be redeemed on the maturity date by payment of the Final Redemption Amount in respect of each Calculation Amount which will be the "Flex Autocall Redemption Amount" calculated based on the change in the value of the relevant Reference Item(s) by reference to the following:

(i) if Relevant Autocall Performance in respect of the final specified autocall valuation date ("final autocall performance") is equal to or greater than the relevant Autocall Barrier, the Flex Autocall Redemption Amount will be an amount determined by the Calculation Agent by reference to the following formula:

where: "y" is the number assigned to the final specified autocall valuation date; or

- (ii) if final autocall performance is less than the relevant Autocall Barrier but greater than or equal to the Put Barrier (being the percentage specified in the relevant Issue Terms), the Flex Autocall Redemption Amount will be an amount equal to the Calculation Amount; or
- (iii) if final autocall performance is less than the Put Barrier, the Flex Autocall Redemption Amount will be an amount determined by the Calculation Agent by reference to the following formula:

CA x final autocall performance

Consequently, if final autocall performance is above the relevant Autocall Barrier, the Flex Autocall Redemption Amount will be determined by reference to a predefined percentage and will not be determined by reference to the final autocall performance or if the final autocall performance is below the Put Barrier, the Autocall Redemption Amount will be less than the Calculation Amount.

Examples of the calculation of the Flex Autocall Early Redemption Amount and the Flex Autocall Redemption Amount:

The following examples illustrate how the Flex Autocall Early Redemption Amount and the Flex Autocall Redemption Amount are calculated in respect of Notes linked to one Reference Item

1.1 Currency-Linked Notes provisions

Reference Item Schedule 4 (*Currency-Linked Notes*) of the Conditions set out in Schedule F (*Terms and Conditions of the Notes*) of the Original Base Prospectus shall be deleted and replaced by the following:

"REFERENCE ITEM SCHEDULE 4 CURRENCY-LINKED NOTES

4. Currency-Linked Notes

4.1 *Applicability*

This Reference Item Schedule 4 (*Currency-Linked Notes*) is applicable only in relation to Notes which are specified to be "Currency-Linked Interest Notes" and/or "Currency-Linked Redemption Notes" or if "FX Conversion" is specified as applicable in the relevant Issue Terms (each, "Currency-Linked Notes").

4.2 Definitions

The following expressions have the following meanings in the context of Currency-Linked Notes only:

"Base Currency" means, in relation to an Exchange Rate, the currency specified as such in the relevant Issue Terms;

"Cross-rate" means the Currency Pairs specified to comprise a Cross-rate in the relevant Issue Terms, where the **Relevant Currency Pairs** are each of the Currency Pairs specified for such Cross-rate in the relevant Issue Terms;

"Currency Business Day" means, in relation to a Currency Pair, a day on which commercial banks are open for business (including dealings in foreign exchange in accordance with the market practice of the foreign exchange market) in the Currency Business Day Centre(s) specified for such Currency Pair in the relevant Issue Terms;

"Currency Pair" means, in relation to an Exchange Rate, the Quote Currency and the Base Currency specified for such Exchange Rate in the relevant Issue Terms;

"Exchange Rate" means, in relation to a Currency Pair and a Valuation Date, unless, in respect of Exempt Notes, the relevant Pricing Supplement provides otherwise, an amount equal to the spot rate of exchange appearing on the Relevant FX Screen Page at the Valuation Time on that Valuation Date for the exchange of the relevant Subject Currency into the relevant Base Currency (expressed as the number of units (or part units) of the relevant Subject Currency for which one unit of the relevant Base Currency can be exchanged) or, if such rate is not available, the arithmetic average (rounded, if necessary, to four decimal places (with 0.00005 being rounded upwards)) as determined by or on behalf of the Calculation Agent of the bid and offer Subject Currency/Base Currency exchange rates (expressed as aforesaid) at the Valuation Time on such Valuation Date provided by two or more leading dealers (as selected by the Calculation Agent) on a foreign exchange market (as selected by the Calculation Agent). If fewer than two such

quotes are provided, the Calculation Agent shall determine the relevant spot rate at such time and by reference to such sources as it deems appropriate;

"FX Rate" means, either (i) where "Cross-rate" is not specified as Applicable for a Currency Pair in the relevant Issue Terms, such Currency Pair or (ii) where "Cross-rate" is specified as Applicable for any Currency Pairs in the relevant Issue Terms, the relevant Cross-rate comprised of such Currency Pairs;

"Reference Price" means, in relation to an FX Rate:

- (a) where "Cross-rate" is not specified as Applicable for the Currency Pair comprising such FX Rate in the relevant Issue Terms, the Exchange Rate for the relevant Currency Pair; or
- (b) where "Cross-rate" is specified as Applicable for the Currency Pairs comprising such FX Rate in the relevant Issue Terms, the "product of", the "quotient of" and/or the "inverse of" (in each case as specified in the relevant Issue Terms) the Reference Price for each of the Relevant Currency Pairs comprising the relevant Cross-rate;

"Relevant FX Screen Page" in relation to a Currency Pair, has the meaning given in the relevant Issue Terms;

"Subject Currency" in relation to a Currency Pair, has the meaning given in the relevant Issue Terms: and

"Valuation Date" means each relevant date specified in the relevant Issue Terms and designated as such in the relevant Payout Schedule or, in respect of Exempt Notes, in the relevant Pricing Supplement or, if any such date is not a Currency Business Day for all the Currency Pairs, the next following Currency Business Day for all the Currency Pairs;

"Valuation Period" means each relevant period specified in the relevant Issue Terms and designated as such in the relevant Payout Schedule or, in respect of Exempt Notes, in the relevant Pricing Supplement;

"Valuation Period Date" means, in relation to a Valuation Period and:

- (i) where the Notes are specified in the relevant Issue Terms to relate to a single Currency Pair, each Currency Business Day falling during such Valuation Period, each such date being a "Valuation Date"; and
- (ii) where the Notes are specified in the relevant Issue Terms to relate to a single Cross-rate or a Basket of FX Rates (whether or not comprising one or more Cross-rates), each day which is a Currency Business Day for all the Currency Pairs falling during such Valuation Period, each such date being a "Valuation Date"; and

"Valuation Time" means, in relation to a Currency Pair and the Reference Price for such Currency Pair, the time specified as such in the relevant Issue Terms.".

1.2 Exchange Rate provisions and definition of "Reference Item"

References to "Subject Currency" in Redemption Payout Condition 1.3 (*Exchange Rate*) and Redemption Payout Condition 1.4 (*General definitions*), in each case, set out in Schedule F (*Terms and Conditions of the Notes*) of the Original Base Prospectus shall be deleted and replaced by the words "FX Rate".

2. Payout Schedule 1 (Interest)

The definition of "Day Count Fraction" set out in Interest Payout Condition 5 (*General Definitions relating to Interest*) set out in Schedule F (*Terms and Conditions of the Notes*) of the Original Base Prospectus shall be amended by the insertion of a new sub-paragraph (viii) at the end thereof, as follows:

"(viii) if "1" is so specified, means 1.".

3. **Payout Schedule 2** (*Redemption*)

- 3.1 Redemption Payout Condition 1.1 (*Application final redemption*) set out in Schedule F (*Terms and Conditions of the Notes*) of the Original Base Prospectus shall be amended by the insertion of the words "(which shall not be less than zero)" after the words "specified in the relevant Issue Terms" in the second line thereof;
- 3.2 Paragraph (iv)(b) of the definition of "Reference Item Initial_i" in Redemption Payout Condition 1.4 (*General Definitions*) set out in Schedule F (*Terms and Conditions of the Notes*) of the Original Base Prospectus shall be amended by the deletion of the reference to "highest" in the second line thereof and the substitution of the word "lowest" therefor; and
- Paragraph (iv)(b) of the definition of "Reference Item Final_i" in Redemption Payout Condition 1.4 (*General Definitions*) set out in Schedule F (*Terms and Conditions of the Notes*) of the Original Base Prospectus shall be amended by the deletion of the reference to "highest" in the second line thereof and the substitution of the word "lowest" therefor.

4. Non-Protected Put Redemption Amount (Reverse Convertible)

Redemption Payout Condition 22 (*Non-Protected Put Redemption Amount (Reverse Convertible*)) set out in Schedule F (*Terms and Conditions of the Notes*) of the Original Base Prospectus shall be amended as follows:

(i) if Relevant Performance is less than 100%, an amount in the Specified Currency determined by the Calculation Agent reference to the following formula:

[CA – (CA x Max [Performance Floor; (PR x Put Performance)])]; or

- (ii) otherwise, if Relevant Performance is greater than or equal to 100%, an amount in the Specified Currency equal to the Calculation Amount."; and
- (ii) Redemption Payout Condition 22.3 (*Definitions*) shall be amended by the insertion of the following definition in alphabetical order therein:

""Put Performance" means a percentage determined by the Calculation Agent by reference to the following formula:

""Put Performance" means a percentage determined by the Calculation Agent by reference to the following formula:

[100% - Relevant Performance];".
